For commercial events, a non-refundable deposit for ½ the total amount is required to reserve the date/time. **Any balance must be paid once services are rendered. Small parties must pay in advance.**

Small parties (backyard/family type) cost \$150 for the first Hour, \$75 each additional hour.

Commercial events (large parties, Weddings, Bat Mitzvah) cost \$200 first hour, \$150 each additional hour.

An **extra machine** (along with another staff member to operate it) is available at the rate of \$100 per hour.

Cloud 9 Cotton Candy services provided:

Minimum of one Cloud 9 staff member to set up/serve candy/ clean up afterward, unlimited # of servings of cotton candy served for duration of hired hours, edible glitter, cones, bags, display of Cloud 9 banner.

Cloud 9 Cotton Candy is required to charge sales tax and accepts PayPal, Credit Cards, Checks and Cash.

Some of the edible glitters we use are cut by machines that process **peanuts**, other glitters are not; so, be sure to let us know if any of the guests have food allergies. Worst-case scenario is loss of life. **Please initial that you have read and understand this risk:** _____

We will need adequate electricity. (The cotton candy machines plug into a standard 3-prong outlet, 120V, 15 amps.) We ask for a dedicated outlet, so that we don't short out the power which can happen easily if too much heavy machinery is plugged into the same outlet—sometimes it can happen even if heavy equipment is plugged into the same WALL or side of a room. Cloud 9 Cotton Candy will not be liable for any electrical issues, or unfortunate circumstances that arise from electric-related things such as the music turning off/"crashing the party". **Do not plug Cloud 9 Cotton Candy in near moonwalks, bouncy houses, etc. because if the power fails, worst case scenario is tragic loss of life.
